**(VARIOUS ROADS) (HARDWICKE WARD AND QUEDGELEY FIELD COURT WARD)**  
**(STROUD DISTRICT AND GLOUCESTER CITY) (VARIATION) ORDER 2024**

NOTICE is hereby given that Gloucestershire County Council intend to make a Variation Order under Sections 1, 2, 3, 4 & 5 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers, the effect of which would vary the Gloucestershire County Council On Street Parking Order 2017 (the 2017 Order) by introducing the proposed restrictions detailed in The Schedule below on various roads in Hardwicke Ward and Quedgeley Fieldcourt Ward, Stroud District and Gloucester City, Gloucestershire.

**THE SCHEDULE**

**Restrictions to be introduced**

***No Waiting at Any Time (Double Yellow Lines)***

<b>Road Name &amp; Number</b>	<b>Extent</b>
Ballis Square (75332)	Along sections of both sides of the carriageway within the immediate vicinity of bends.
Bridge Keepers Way (43307)	Along sections of both sides of the carriageway between Haywicks Lane (C223) and Patch Bridge Close (75280).
Bristol Road (B4008)	Along sections of both sides of the carriageway within the vicinity of the junction with Elmgrove Road East (42438).
Elmgrove Road East (42438)	Along sections of both sides of the carriageway between its junction with Bristol Road (B4008) and Cornfield Drive (45804).
Foxwhelp Way (482711/75331)	Along sections of both sides of the carriageway between its boundary with Ballis Square (75332) and its junction with Meerbrook Way (486078)
Haywicks Lane (C223)	Along sections of both sides of the carriageway.
Meerbrook Way (486078)	Along sections of the western side of the carriageway either side of its junction Foxwhelp Way (482711/75331).
Wharfdale Way (48367)	Along a section on the eastern side of the carriageway between its junction with Bekdale Close (48368) and Dovedale Close (48366).

***No Waiting (Mon-Fri 8am-4pm)***

<b>Road Name &amp; Number</b>	<b>Extent</b>
Green Lane (41326)	Along sections of both sides of the carriageway between its junction with Church Lane (41205) and Hardwicke Village Hall.

The lengths of roads fall within the Hardwicke Ward and Quedgeley Fieldcourt Ward within Stroud District and Gloucester City in the County of Gloucestershire.
